LOCAL MATCHING FUNDS CALL MODEL

The Consulate of Mexico in Kansas City, with the support of the Secretariat of Foreign Affairs, through the Institute for Mexicans Abroad, invites educational institutions and social organizations interested in participating in IMME Scholarships 2026 to apply for financial support **for Mexican nationals or individuals of Mexican origin enrolled in one of their academic programs**, at the following educational levels:

EDUCATION FOR EMPLOYMENT

Programs and/or technical training workshops in trades that enhance employability, including HiSET exam preparation programs and General Educational Development (GED) exam training.

HIGHER EDUCATION

Universities, community colleges, university extension programs, technical education, and specialized courses (including online courses).

GUIDELINES

- Education institutions and social organizations may present their IMME Scholarships 2026 application form at the Consulate of Mexico. In annex 1 the total amount for 2026 is stated as well as the information where the application form may be presented.
- Only those applications officially supported by the Consulate of Mexico, and which are committed to contribute with **at least the same amount as the one requested**.
- Incomplete applications or those submitted after the application deadline will not be accepted; for mailed submissions, the Postal seal's date will be taken into consideration, not the date of receipt at the consular offices.

Participating organizations/institutions are responsible of confirming that the Mexican Consulate received their application form.

REQUIREMENTS

1.-Submit the funding application, signed by the representative of the institution or organization, along with its annexes:

- Copy of the institution's/organization's **bylaws**.

2.- Include a proposal (not longer than three pages) enclosing the following elements:

- Mission of the educational institution or nonprofit social organization.
- Description of:
 - The organization or institution, its objectives, programs, activities, and achievements in the field of education and in the educational development of Mexican migrant communities.
 - Its projects and plans to meet the expected goals (anticipating the results that would be achieved with IMME Scholarships funds and complementary resources), as well as the procedures for evaluating the achievement of the objectives.
- Other contributions received and anticipated by the institution/organization to help achieve the project's objectives and related activities.
- A budget detailing the proposed expenses of the applying institution or organization, including a brief explanation of the purpose of such expenses. It must also indicate how the financial support will be distributed among students, and when the corresponding support payments will be made, depending on the option.

Deadline for receiving applications: May 4th, 2026.

SELECTION PROCESS

The Consulate will verify that applications comply with the requirements of the Call for Applications. The selection of institutions and organizations will be carried out by a **Local Committee** composed of at least three distinguished individuals from the consular jurisdiction, with ties to education and community work. The Local Committee must be inclusive and address local educational needs.

- Preference will be given to institutions and organizations that can match the funds requested from IMME Scholarships; that is, those that, through other funding sources, complement the funds at an equal or higher level than those presented in their application.
- In the case of community organizations providing education for employment, upon their explicit request, the Local Committee may consider operating costs (teacher compensation, infrastructure) as equivalent to contributed funds.
- Only institutions and organizations whose work plan complies with the objectives and guidelines of this Call for Applications will be considered.
- The number of Mexican nationals or individuals of Mexican origin who will benefit will be taken into account, in accordance with the selected modality.
- To determine the amount of support, consideration will be given to the written commitment stated in the application regarding the amount that institutions and organizations will contribute to their financial support program.

DISPUTE RESOLUTION



Any matter not provided for in this Call for Applications shall be resolved by the Head of the Consulate, in accordance with their powers and responsibilities.
