

Visa for Visitors without permission for lucrative activities

General Requirements:

- 1. To schedule an appointment please send an email to: visaslasvegas@sre.gob.mx
- 2. Print and fill out the visa application form: https://consulmex.sre.gob.mx/lasvegas/index.php/servicios-extranjeros/visas
- 3. One passport-size photograph: white background, clear view of the face (glasses or other accessories are NOT ALLOWED, filters or image alterations are NOT ALLOWED.)
- 4. Comply with original or certified documents required according to the category.
- 5. Visa fee: <mark>\$54 USD</mark>

The appointment does NOT guarantee the issuance of the visa; it is the applicant's responsibility to provide the required documents on the day of their interview. Applicants must present original documents and if required, the proper certifications and/or apostilles. The processing time of a visa may take
1-10 business days from the day of the appointment.

	 A. Proof of employment or pension with a minimum monthly income of \$1,360 USD for the last 3 months (bank statements, payroll, and employment letter stating the person has been employed for at least a year).
	B. Proof of investment: Bank statements with an average monthly balance of overall \$ 4,080 USD (3 months).
	C. <u>In the case of applicants who are students at a higher education institute</u> , <mark>must provide</mark> original proof of studies and original proof of stable employment, pension, or scholarship with a monthly equivalent of at least \$816.80 USD (3 MONTHS).
Frequent Traveler	Provide visas issued by at least three different countries (not adjacent countries, meaning not on the
	same border) or stamps from the immigration control of at least three different countries (not
	adjacent countries).
Letter invitation from an	- <u>Letter invitation from a public or private organization or institution inviting the foreigner to</u>
organization or a public	participate in a non-remunerated activity in Mexican territory. The letter must include:
or private institution	-Applicant's name and nationality, institution's name, registration number, the purpose of the organization, address and contact information of the organization, activity, and length, and the commitment to provide support for the foreigner during his/her stay in Mexico and to ensure that the foreigner returns.
	-Copy of the official identification of the person who signed this letter, if the organization or institution will cover living expenses, the institution must prove income of an average monthly balance of over \$ 13,613 USD (12 months) unless the inviting invitation is a school.
	-Proof of experience, skills, or expertise.

	- Copy of the official identification of the person signing this letter.
	- Must also provide proof that bus/truck drivers have enough economic solvency.
Humanitarian Cases	Choose one:
	1. Sickness of a relative: birth or marriage certificate and health certificate.
	2. Identify a body: birth or marriage certificate and official notice.
	3. International volunteer (international medical education or any type of emergency): Proof

Scientific research in	Communication through which the Embassy of the applicant's country of nationality or residence in

	Solvency may be accredited by the applicant, by his parents, by his spouse, common-law wife or
	common-law partner or equivalent figure; by whoever exercises parental authority or
	guardianship, or with a letter from the educational institution that proves that they have been
	the beneficiary of a scholarship or document from a banking or financial institution that proves
	that they have the financing.
