

Visa for Visitors without permission for lucrative activities

General Requirements:

1. To schedule an appointment please send an email to: visaslasvegas@sre.gob.mx
2. Print and fill out the visa application form:

3. Comply with original or certified documents required according to the category.
4. Visa fee: **\$56 USD**

The appointment does NOT guarantee the issuance of the visa; it is the applicant's responsibility to provide the required documents on the day of their interview. Applicants must present original documents and if required, the proper certifications and/or apostilles. The processing time of a visa may take 1-10 business days from the day of the appointment.

Economic Solvency	Choose one option: <ol style="list-style-type: none"> A. Proof of employment or pension with a minimum monthly income of \$1,309 USD for the last 3 months (bank statements, payroll, and employment letter stating the person has been employed for at least a year). B. Proof of investment: Bank statements with an average monthly balance of overall \$ 4,045 USD (3 months). C. In the case of applicants who are students at a higher education institute, must provide original proof of studies and original proof of stable employment, pension, or scholarship with a monthly equivalent of at least \$773 USD (3 MONTHS).
Frequent Traveler	Provide visas issued by at least three different countries (not adjacent countries, meaning not on the same border) or stamps from the immigration control of at least three different countries (not adjacent countries).
Letter invitation from an organization or a public or private institution	<ul style="list-style-type: none"> - <u>Letter invitation from a public or private organization or institution inviting the foreigner to participate in a non-remunerated activity in Mexican territory. The letter must include:</u> <ul style="list-style-type: none"> -Applicant's name and nationality, institution's name, registration number, the purpose of the organization, address and contact information of the organization, activity, and length, and the commitment to provide support for the foreigner during his/her stay in Mexico and to ensure that the foreigner returns. -Copy of the official identification of the person who signed this letter, if the organization or institution will cover living expenses, the institution must prove income of an average monthly balance of over \$ 13,622 USD (12 months) unless the inviting invitation is a school. -Proof of experience, skills, or expertise.
Bus/truck driver	<ul style="list-style-type: none"> - Driver's license. - Original letter from a bus/truck driver's public or private organization that must include: The applicant's name, registration number, address, contact information, what is being transported, and routes they are taking.

	<ul style="list-style-type: none"> - Copy of the official identification of the person signing this letter. - Must also provide proof that bus/truck drivers have enough economic solvency.
Humanitarian Cases	<p>Choose one:</p> <ol style="list-style-type: none"> 1. Sickness of a relative: birth or marriage certificate and health certificate. 2. Identify a body: birth or marriage certificate and official notice. 3. International volunteer (international medical education or any type of emergency): Proof of government invitation.
Scientific research in jurisdictional waters of Mexico	<p>Communication through which the Embassy of the applicant's country of nationality or residence in Mexico notifies the foreigner that the Mexican Ministry of Foreign Affairs (SRE) received authorization from the competent national authorities.</p> <ul style="list-style-type: none"> - The letter must include: Applicant's name & nationality, institution name and registration number, activity, and length.
Studies	<ul style="list-style-type: none"> - <u>Original and copy of acceptance letter from an institution that belongs to the National Educational System to perform courses, studies or projects of investigation or academic training or professional for a period no longer than 180 days, on letterhead of the institution specifying:</u> <ul style="list-style-type: none"> • Full name and nationality. • Level grade and study field. • Name of the course or academic activity in which he/she has been accepted. • Start and termination date of the course or academic activity. • Tuition cost for the course or academic activity. • School contact information. - <u>Economic solvency to cover the tuition cost and accommodation costs during the stay in national territory accredited through:</u> <ul style="list-style-type: none"> -Original and copy of proof of investments or bank accounts with an average monthly balance of \$2,022 USD during the last 3 months or -Original and copy of the documents that show that you have a job, pension, or scholarship with a monthly average of \$1,309 USD, during the last 3 months. <p>Solvency may be accredited by the applicant, by his parents, by his spouse, common-law wife or common-law partner or equivalent figure; by whoever exercises parental authority or guardianship, or with a letter from the educational institution that proves that they have been the beneficiary of a scholarship or document from a banking or financial institution that proves that they have the financing.</p>
