



HOUSEHOLD GOODS CERTIFICATE APPLICATION

Permanent and Temporary Residents of Mexico have the right to import their household goods duty-free once, within a period of no more than six months after the date of their formal entrance to Mexico. Household effects are defined as those items that constitute the furnishings of a house and are exclusively for use, on their daily needs, by a person or family. This includes clothes, bedding, books. All of the items must have been purchased at least 6 months before moving.

Items that **CANNOT** be included in a *Menaje de Casa* are vehicles, weapons, ammunition, alcohol, any items considered for commercial activities, chemicals or gases, among others.

Requirements:

1. Application
2. Valid passport & copy
3. Copy of visa or residency card *(must have been issued within the previous six months)*
4. Household goods inventory
5. Payment \$195 *(at the day of your appointment)*

To schedule an appointment send an email with all the required documentation to visaspot@sre.gob.mx with 'Menaje de Casa - Extranjero' in subject line. Must bring originals and sets of copies at the time of your appointment.
