### **Mexican Passport:**

**Step 1:** Determine if it is a first time or a renewal application.

**Step 2:** You must apply in person at the consulate and provide the requested documents as listed below:

#### **First Time:**

I. Provide evidence of Mexican citizenship, with any of the documents listed below:

- Original Mexican Birth Certificate (Certified copy) Issued by a Mexican Civil Registration Records Office (vital records) or by a Consulate of Mexico.
- Official Declaration of Mexican nationality.
- Certificate of Naturalization
- Consular ID (Matrícula Consular)

II. Present one of the following the documents listed below as identification.

- Consular Registration (matricula consular)
- Voter ID card (INE/IFE)

- Mexico Military Service Record Document (Cartilla Militar liberada))
- Professional Identification Card (Cedula profesional).
- Mexican passport issued after 1995 in Mexico or after 2006 at a consulate
- Official identification issued by a local authority. (Valid Driver Licence or ID issued by MVD).

**Step 3:** Determine the validity period for your passport: 3, 6 or 10 years.

**Step 4:** Payment of Fees (US dlls.)

- a) 3 years: \$74.00;
- b) 6 years: \$101.00;
- c) 10 years: \$136.00;

## **Consular Id (Matrícula Consular):**

**Step 1:** Determine if it is a first time or a renewal application.

**Step 2:** You must apply in person at the consulate and provide the requested documents as listed below:

### **First Time:**

I. Provide evidence of Mexican citizenship, with any of the documents listed below:

- Original Mexican Birth Certificate (Certified copy) Issued by a Mexican Civil Registration records Office (vital records) or by a Consulate of Mexico.
- Official Declaration of Mexican nationality.
- Certificate of Naturalization
- Consular ID (Matrícula Consular)

II. Present one of the following the documents listed below as identification.

- Consular Registration
- Voter ID card

- Consular Registration (matricula consular)
- Mexico Military Service Record Document (Cartilla Militar liberada))
- Professional Identification Card (Cedula profesional).
- Mexican passport issued after 1995 in Mexico or after 2006 at a consulate
- Official identification issued by a local authority. (Valid Driver Licence or ID issued by MVD).

**Step 3:** Proof of Address. The name on the document must be that of the interested party member on the application. Bank Statements, Utility Bills

**Step 4:** Payment of Fee \$27.00 US dls.

## **Civil Registration (Vital Records)**

A child born abroad to a Mexican parent or parents can be granted a Mexican Birth Certificate.

We strongly recommend that parents apply for a birth certificate as soon as possible after the child is born in order to obtain dual citizenship.

You should prepare the following documentation and schedule an appointment at the consulate to submit the application.

**I.– Evidence of Mexican Citizenship of father, mother, or both** with any of the following documents:

- Birth certificate and ID with photo.
- Certificate of Mexican Nationality.
- Valid passport
- Official Declaration of Mexican nationality.

Consular ID (matrícula consular)

**II.– Present registrant's U.S birth certificate**, with location, time and Date of birth (this Birth Certificate will not be returned).

**III. Present an official registrant identification** containing his/her signature or fingerprint.

**IV.– Present Marriage certificate of the parents and/or divorce certificate**, if child born during marriage.

**V.– Two witnesses are required**

- Persons over 18 years of age, (other than parents or grandparents) with valid official photo ID.

Provide original documentation and two photocopies of each. Once you have provided the documentation and submitted the application, an appointment will be scheduled to issue a birth certificate.

**Declaration of Nationality:**

Mexicans who obtained another citizenship prior March 20, 1998 lost their Mexican citizenship. Individuals, who wish to recover it, must apply for a Declaration of Nationality. Other than that, Mexicans no longer lose Mexican citizenship (if they became citizens of any other country after 1998).

**Requirements:**

- Certified Copy of Birth Certificate.
- Valid-official ID with photo and signature.
- A recent passport size photo taken against a plain white background with no hair covering your forehead, so that the applicant's features are clearly distinguishable included forehead and ears. No glasses, or clothing over head will be accepted.
- Women holding documents with their husband's surname must present original **Marriage Certificate**.
- Original, Certified and apostilled U.S Naturalization Certificate issued before March 20, 1998. This document must be translated by official translator.

Certified copies of Naturalization Certificates are issued by USCIS .

**Credencial INE (Mexican Voter ID)**

**It s really easy to apply for an INE CARD when you live abroad.**

National Electoral Institute issues voter id's through Mexican embassies and consulates.

**I** Provide evidence of Mexican citizenship, with any of the documents listed below:

- Original Mexican Birth Certificate (Certified copy) Issued by a Mexican Civil Registration Records Office (vital records) or by a Consulate of Mexico.
- Official Declaration of Mexican nationality.
- Certificate of Naturalization
- Consular ID (Matrícula Consular)

**II.** Present one of the following documents listed below:

- Consular Registration (matrícula consular)
- Mexico Military Service Record Document (Cartilla Militar liberada)
- Professional Identification Card (Cedula profesional).
- Valid Mexican passport
- Official identification issued by a local authority. (Valid Driver Licence or ID issued by MVD).
- Proof of address.

### Importing household effects into Mexico

If your moving back in Mexico permanently, you may qualify for our household effects importation program.

I . Provide evidence of Mexican citizenship and an official ID as when applying for a Mexican passport. (see passport section on page 4)

II Present proof of address with applicant's name for the last six months (e.g. mail, utility bill, car insurance)

III Present 4 copies of a list containing your household effects, stating make, model and serial number of home appliances and/or devices.

IV. Determine the location where you will be moving in Mexico.

V. Pay your fees.

**In every case a customs broker will be required.**

### Notary Public

In this department you may apply for a power of attorney:

A power of attorney is a document that allows you to appoint a person to manage your affairs if you become unable to do so. However, all power of attorneys are not equal. Each type gives your attorney-in-fact (the person who will be making decisions on your behalf) a different level of control.

1. General or special powers of attorney (and revocation)
2. Will
3. Renunciation of inheritance
4. Temporary Guardianship of minors or Incapacitated or Disable persons

### Mexican Visa

**Eligibility:**

Every person, regardless of citizenship, who holds a current valid visa or permanent residency of any of the countries listed below are allowed to enter Mexico for business or tourism purposes for up to 180 days without visa.

- Canada
- Japan
- Schengen Area (European Union)
- United Kingdom
- United States of America

The Mexican Consulate in Tucson has the mission to provide protection, assistance and guidance to Mexican citizens in Pima and Pinal Counties on labor, criminal, civil, immigration, and administrative matters.

### Legal Defense Center

The Legal Defense Center offers personalized and direct legal advice and advocacy in civil cases with the support of a strengthened network of local and national allies to support Mexicans abroad.

### Mobile Consulate

Consular assistance services are provided outside our building through Mobile Consulates set up temporally in different locations and dates throughout the Pima and Pinal counties. Information on human rights, immigration, dual citizenship, legal representation and documents issuance can be offered to Mexicans leaving outside the Tucson metro area.



### Binational Health Week

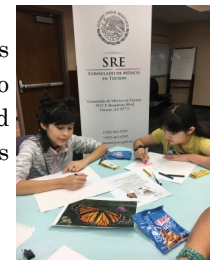
This year, about 300 people attended this event held at the San Miguel High School in southern Tucson.

### Klezmermerson Block Party

**Saturday October 7, 2017**

For the third consecutive year, the Consulate of Mexico in Tucson and the Jewish History Museum presented *Klezmermerson*, a Mexican band with Eastern European Jewish and Latino music influences.

Over 600 people attended this block party was held on the Stone Avenue, in front of the Jewish History Museum and the former Consulate of Mexico building.



### Home Buyer's Workshop October 10 and 11, 2017

Two workshops on home buying were offered at the *Chicanos por la Causa Inc* facility. 40 people benefited with information on mortgages, loans and Pima and Pinal housing resources.



### Breast Cancer Awareness Day/Month Friday October 13, 2017

This office joined the Breast Cancer Awareness Day and Month with information sessions held at our facility. General public and Consulate Staff were informed on prevention practices of this disease. Raffles for free screenings were conducted as well.



### Naturalization Forum Saturday October 14, 2017

This forum was organized by Mi Familia Vota, organization intended to provide free legal assistance on the naturalization process in the U.S and Arevalo and Associates Law Firm, both offered free consultations for about 35 people.



### Barrio Centro Fall Fiesta Saturday October 21, 2017

The Consulate of Mexico participated in the *Barrio Centro Annual Fall Fiesta* held at Bristol Park in Tucson.

During this event, consulate's staff set up a booth to provide general information on consular services and assistance. More than 500 people attended this festival.



### 3rd Annual Missing in Arizona Day Saturday October 21, 2017

For the second consecutive year, the Consulate of Mexico in Tucson and the Consular Assistance and Information Center (CIAM) were invited to take part in this initiative organized by local law enforcement agencies (led by the Maricopa Sheriff's Office), to encourage families of missing persons in Arizona to come forward and make or update a report providing any evidence they might have, including notes, time lines, medical records and photos.



Consulate and CIAM staff collected information to open new cases, especially of people who have gone missing while crossing the border. More than 100 people attended this event held at ASU's West Campus in Glendale.

### Presentation on Consular Services at Santa Monica Community Center Tuesday October 24, 2017

Consulate staff made a presentation on Consular Services such as issuance of: passport and consular ID, as well as dual citizenship, legal orientation and assistance in the event of a detention or other legal processes.



Information about our health and financial education programs was provided as well.

### Anxiety and Depression Workshop Sunday 26 October, 2017

In association with the Wakefield Resources Center and Dr. Francisco Moreno with the University of Arizona Hispanic Center of Excellence and the Tucson Arizona Chapter Red Global, the health window offered a Workshop on Anxiety and Depression at the Wakefield Resources.



About fifty attendees, especially housewives, were provided with information on these mental health conditions.

### Kermesse at Catholic Parish of Our Lady of Fatima October 28 and 29, 2017

During this Kermesse, Consulate Staff provided information on Consular assistance, such as applications for passport or consular ID, dual citizenship, and our legal guidance services in the event of an emergency.

Our health and financial education programs as well as the Consular Assistance and Information Call Center 24/7 were promoted too. More than 250 people attended this event.





### **Festival de Día de Muertos at the Tucson Museum of Art November 2, 2017**



The Consulate of Mexico in Tucson was invited to set up an *Altar de día de Muertos* in this annual Festival organized by the Tucson Museum of Art. In this event, other cultural and educational institutes participate as well.

We dedicated our ofrenda (altar) to two Mexican Figures of Art and Literature: Leonora Carrington, English-born Mexican painter and novelist. (6 April 1917 – 25 May 2011). And Juan Nepomuceno Carlos Pérez Rulfo Vizcaíno, best known as Juan Rulfo (16 May 1917 – 7 January 1986). Mexican writer, screenwriter and photographer.

### **Elementary and Middle School Promotion Ceremony at La Palma Correctional Center Friday November 3, 2017**

Consulate Staff participated in the Elementary and Middle School Graduation Ceremony at La Palma Correctional Center. Inmate students were presented with their respective diplomas.



### **Festival Telemundo Saturday November 18, 2017**

Consulate Staff and the Mobile Health Unit took part in the *Telemundo Festival*. This event was intended to promote preventive health services.



### **MAEX Help Desk Inauguration Wednesday November 15, 2017**

A Mexican Financial Services Help Desk (MAEX) was inaugurated at the Mexican Consulate in Tucson. This help Desk is operated by the Financial Services Consumers Protection and Defense National Commission (Condusef) in Mexico.

Celestino Rodríguez, deputy officer at the Condusef, and Ricardo Pineda, Consul of México in Tucson, inaugurated the MAEX during a Financial Education Fair, held November 15-17, hosted by the Consulate.

At this help desk, Mexicans will be able to apply for a copy of their credit report in Mexico at no cost, and will be provided with information to improve their financial management.

This is another initiative implemented by the Mexican Government through the Institute for Mexicans Abroad (IME) to promote the welfare of Mexican communities in the U.S.

The MAEX is one out of the nine Mexican Financial Services Help Desks set up in the United States, and the only one in Arizona. This Help Desk will be assisting more than 400 thousands people of Mexican origin living in Pima and Pinal counties.



### **Legal Guardianship of Minor Children Workshops**

**Saturday November 18, 2017**

In this workshop, attendees received information on legal guardianship for minors in the event of a detention, or deportation, of one or both parents. Consulate's staff and a Notary Public offered assistance on how to give power of attorney to other relatives or friends.



**Immigration Legal Advice Workshops,  
October 20, November, 18 and December 2 , 2017**

During these sessions, Attorney Doralina Luna offered free consultations to Mexican citizens on immigration processes. Consulate staff provides general information on immigration policies and legal processes as well.



**Citizenship Workshops**  
**October 14, 28 and November 11 and 18,**

During September and November, in association with Mi Familia Vota Organization, four workshops were conducted to provide assistance and information on U.S. citizenship applications and process.

In these workshops, people reviewed their cases with an attorney or specialist, to verify if they meet the criteria to submit an application for U.S. citizenship.

Do not forget to stop by its Markets, where you might grab some wonderful souvenirs. The farmers Market renowned for its high quality fresh fruits vegetables, and food where you can have local dishes as you can try a wide variety of tamales, drinks quesadillas and much more.
